CME paperwork has been updated with 51-4 and approved by the Board of Health as the registered vehicle on medical calls. A sticker will be placed on the vehicle showing the approval and will need to be updated every 2 years.

Data Demon is moving from their Legacy program to cloud based software. The Legacy program will no longer exist. The cost to move to the cloud based program is \$1,000/year. Approval was given on a motion by L. Gates/C. Ryan to move to the cloud based Data Demon program for a cost not to exceed \$1,000.
