# Chief's Report:

There were 9 alarms for July and 69 YTD.

G. Kreig has completed and submitted the necessary information for the Volunteer Firefighter Assistance Grant that is due 8/10/18.

The approximate cost to purchase lighting and nomax hoods is \$3,280.

Saratoga County has changed the way departments will be dispatched for EMS calls.

We are still waiting on saws and the thermal imaging camera for the new truck.

We need to purchase Narcan. The cost to replace the 6 that have expired is \$428.94.

G. Kreig sent an email to Clifton Park Ambulance concerning the condition they leave our building in.

Keys had to be ordered for the Knox Box. A. Cote will be the ship to address.

Log Me In comes due next month. The annual cost for the program is \$350. G. Kreig will research other programs.

Rexford will be hosting the County Officer's dinner next Monday and are responsible for supplying the dinner. There will be approximately 30-40 in attendance.

Truck PM's will be due soon.

Approval was given on a motion by P. Van Schaick/R. Cote to purchase Narcan for a cost not to exceed \$600.

Approval was given on a motion by R. Cote/S. Lessard to renew Log Me In or purchase another program for a cost not to exceed \$350.

Approval was given on a motion by L. Gates/P. Van Schaick to terminate the  $2^{nd}$  Assistant Chief position for the remainder of the year and to move A. Cote to the  $1^{st}$  Assistant Chief position.

### **Board Member Reports:**

#### P. Van Schaick

P. Van Schaick noted an increase in the LOSAP program this month.

Information has to be submitted to the insurance company concerning the NY Cancer Bill. The cost per firefighter for this insurance will be approximately \$225.

### M. Trombley:

There will be training on the electronic sign. Two people from each group will be given the training.

#### S. Lessard:

The Auxiliary has asked if a key to the pantry could be left somewhere for their access to the pantry.

#### R. Cote:

R. Cote received \$300 for use of the community room to be deposited to the general fund savings account.

The exterior doors have been fixed.

The doors will be painted as soon as the weather permits.

The owner of the lot next door would like to share the cost of a new fence between the properties.

Since we have done major maintenance on the building this year, R. Cote suggested we wait until next year to apply for a building permit to complete the pavilion.
