Chief's Report:

There were 9 alarms for October with 111 alarms YTD.

The Recruit Grant in the amount of \$2,727, has been received from Saratoga County.

The Wildland Grant has been submitted and should be awarded in December.

The 2 ½" pump used for pump outs needs to be replaced.

The boots, pagers and LED lights have been received.

Fittings for new gear will take place tomorrow night.

Board Member Reports:

M. Trombley:

Last month M. Trombley questioned why events aren't posted on our website. Don Seguin stated that people are directed to the social media pages for the events.

M. Trombley asked what kind of hazmat training firefighters receive. A. Cote stated that firefighters had training on propane 2 weeks ago. He also stated that every couple of years the hazmat truck is brought in for training and a review of how to use the equipment.

L. Van Schaick:

L. Gates:
