# **Chief's Report:**

There were 9 alarms in October with 122 alarms YTD.

The response to recent alarms has been great.

We did not get the federal AFG grant or state V-Fire grant.

The live burn with Burnt Hills on 10/28 was great.

We held a CPR training on 10/24 for Faith Baptist Church.

The annual Sexual Harassment training will be 12/3 at 7 p.m.

Firefighter physicals will be given on 12/10.

The Wildland Grant has been submitted.

A. Cote is still working with AT&T to move our cell phones from T-Mobile and expects the process to be completed in January 2025.

The AFG Grant reopens on 11/12. A. Cote contacted a grant writer and the cost to write the grant would be \$3,500. The grant must be submitted within 3 weeks and Susan Westbrook has agreed to write the grant.

The purchase of radios was discussed and A. Cote requested the discussion be tabled until next month so he could investigate pricing.

On 11/17, 51-2 will be going to the Toys for Tots event and to the Schenectady Holiday Parade on 11/23.

J. Borowiec reported just under 300 people were served at the pancake breakfast on Sunday with 24 members and 6 students working the event. The extra food was donated to the City Mission.
