Chief's Report:

There were 22 alarms in June (12 medical and 10 fire rescue) with 87 alarms (34 medical and 53 fire rescue) YTD.

Congratulations to our new EMT. Ethan passed his written exam and is now shadowing Aaron on calls and doing well. A. Cote will complete the paperwork necessary to receive the reimbursement for tuition paid for the training.

Veronica is doing BEFO/IFO training and will be taking the suburban to training in Wilton.

James Russ started Fire Police training tonight.

Hose and pump testing have been completed and everything passed.

The bi-yearly pack batteries will be changed on Wednesday.

The new firefighter gear has arrived for CJ and Veronica.

Last February A. Cote contacted a company that was paying \$300 for used radios. The price has now dropped to \$100.

Oil changes and yearly inspections were completed on 51-5 and 51-6. The lights on 51-6 wouldn't shut off after an alarm. Buying a new light bar was discussed if they couldn't be fixed.

PM's have been completed on 51-1 and 51-2. A leak was found on 51-2 and it is still at Vander Molen. The cost to repair the leak is \$2,500.

A. Cote received 3 phone calls to fill swimming pools. Per the Rules & Regulations, the filling of pools is not allowed because of a liability risk.

Firefighters will be going to the Saratoga County Fair next Tuesday to man the fire booth and going to National Night Out on 8/4 at Clifton Commons.

Clifton Park Ambulance is creating a contract to oversee the necessary information for our CME program. We have been using their service since 1/1/26 and request approval of the contract for a cost of \$500. Approval was given on a motion by M. Trombley/P.
